### **Brief Business Meeting:**

Kathy Proctor suggested the Garden Club seek counsel from a CPA in the neighborhood about IRS rules regarding funds in the Club account.

She also announced possible future programs, such as a tour of Harold Duckett's backyard garden during National Garden Club week, which is the first week of June.

Linda Haynes offered John Haynes to lead a program on mushroom planting. The program for Thursday, April 15, will be a walk and visit to the River Bluff Small Wild Area on the TVA Norris Dam property to see the wildflowers.

### **Greenway Report:**

Kathy reported that the Greenway is complete over the Alcoa Highway Bridge to the CVS on Alcoa Highway but there is a "missing link" between CVS and the Maloney Road Park before it begins again toward Blount County. A committee of residents in our neighborhood has been formed to address this "Missing Link", seeking to connect the two together.

Clean Up Day in the neighborhood is Saturday, March 27, 2021. Tanya Copeland announced Buz would have a dump truck at Maxey's Boat Dock on that day.

The meeting was adjourned for the members to begin clean up of the Legacy Park in anticipation of visitors during the Dogwood Trail openings of the month of April.
